GENERAL SITE RULES

Condition of hiring stalls, open space reservation & payment of space.

NO site is reserved or deemed to be reserved until payment has been received.

Insurance certificate

A photocopy of a valid insurance certificate must be sent to the section organiser along with all other paperwork.

Preparation of trade stand.

Traders will not be able to gain access to the site until 1pm on Friday 21st May 2010, the show ground will be open to the public on Saturday/Sunday at 10pm, and all trade stands must be in place by 9am on Saturday 22nd May 2010.

Movement of trade stands in the show ground.

No traders must move their stand once the site has been allocated.

Dismantling of stands.

All trade stands must vacate the site on Sunday evening after the event has closed.

Vehicles.

Vehicles may only park within the show ground provided they are within their allocated area for use with the stand, all other vehicles including stock vehicles, are to park in the designated area provided.

Public address systems.

Traders are not permitted to have a P.A system, music or other noises coming from their stands, music demonstrations maybe permitted at the section organiser's discretion.

Litter

Traders are expected to leave their allocated pitches free of all rubbish and litter, failure to do so could affect next year's invitation.

BBQ'S

Charcoal bbq's of any type **will not be permitted** on the rally field, camping or parking fields occupied by the show.

Condition of trade stand

All structures used to display goods on sale must be of safe and sound construction, and appropriate for safe loads, goods that are laid out on the ground must not cause trip hazards or be stacked in an unsafe manner.

All traders must supply their own fire extinguishers; they must be fully operational for the aspect of your pitch, stock and equipment.

It is a condition of letting the stand and display space that the tenant shall have Public Liability Insurance to cover activities for a limit of not less than £2,000.000 for any Accident.
